Account Procedures

This pamphlet lists the standard consultation fee for seeing your doctor, as well as the cost of some of our other services. For the price of a service or procedure not mentioned here, please check with our receptionists.

You will also notice a 'Medical Fees' board at the entrance to our waiting room, which shows consultation fees, discounts, etc.

t is our preference that accounts are paid on the day of the service. We accept cash and have EFT-POS and credit card facilities. You can also arrange a regular automatic payment to keep your account up to date or in credit.

f payment in this time frame is not possible, then please discuss with the Practice Manager to arrange a payment plan to suit you —regular automatic payments through your bank, or regular payments in cash are options that can be discussed.

NB—there is a \$5.50 administration charge for processing overdue accounts each month

Our policy is that if you need medical attention, you must not hesitate to make an appointment with your doctor. We will not refuse medical attention because of an outstanding account. However, consistent failure to pay for services provided may result in a breakdown of the doctor-patient relationship, meaning you may be unenrolled and will need to find a different practice.

NB—patients requiring same-day medical attention when we are already fully booked will be charged an extra \$27.00 for an urgent assessment with a nurse, regardless of whether or not they go on to consult with a doctor.

Patients who do not attend their appointment without giving sufficient notice may incur a fee of 50% of usual cost.

There is a \$10 surcharge for prescriptions required urgently, rather than in the usual 48 hour processing time.
